Enclosed is a memorandum of this Bureau dated May 13, 1971, which contains information regarding contacts made by the Labor Attache of the Embassy of Israel in Washington, D. C. during these contacts was information indicating possibility of discussion by the Israeli official with Senator Mark O. Hatfield, Oregon; Israeli financing of a trip to Israel for Senator Robert W. Packwood, Oregon; and attempts to hold a dinner with local Jewish leaders in Las Vegas, Nevada, for an unidentified Senator from the State of Washington. (S)

On May 12, 1971, a confidential informant, who has furnished reliable information in the past, learned that one Harry Walker advised Amos Eiran, Attache (Labor) Embassy of Israel, that he, Walker, had visited Senator Mark O. Hatfield, Oregon, last night and had "brought it up". Walker said Hatfield explained that he had been to a symposium at a college in North Carolina, arranged by Walker's office and had noted the absence of a pro-Israel spokesman. According to Walker, Hatfield said he hoped no one thought he was pro-Arab, pointing out that he had, at one time, spoken for Israel Bonds and that Hatfield stated he would like to mention this to Israeli Ambassador Yitzhak Rabin. Walker told Eiran he thought that Hatfield is "in the right mood" to be talked to and that it would be worth while for Rabin to talk with him. Walker continued that he had alerted Hatfield to the fact that what he was doing was wrong and that Hatfield had replied that he did not think he has espoused the "Arab line", to the detriment of Israel, pointing out that after a visit to Israel he had submitted a paper on the refugee question. Eiran retorted that after the visit, Hatfield put at least ten items in the "Record" of pro-Arab interest or in behalf of pro-Arab groups. Eiran also pointed out that Rabin would not talk to Hatfield, but that he, Eiran, would be glad to talk to him. Walker further stated that he had told Hatfield, "We'd be satisfied if you were even neutral".

(S) [Walker] continued that he had also spoken with [S] Packwood, probable reference to Senator Robert W. Packwood, Oregon and that Packwood's United Jewish Appeal speech [S] is all set. [Walker] said he told Packwood to feel free to contact [Eiran] for any assistance on [Israeli] matters. [Eiran] [S] noted that Packwood was sent some material a month ago and has been put on the Embassy's mailing list for the "Pink Sheet". [Walker] stated that Packwood is anxious to do as much as "you" want him to do during his visit to Israel in [June] and [Eiran] said Packwood would get the "best treatment all around". (S) (X)

Later, according to informant, [Walker] informed [Eiran] that in checking, he had determined that Packwood's fare to Israel would be handled by the "JNF" and the "ZOA" and that Packwood and his wife would arrive in Israel on June 24 and depart on June 30, 1971. [Eiran] acknowledged that the Israeli Government would take care of Packwood's expenses while there. (S) (X)

On the same date, informant learned that [Eiran] told an individual believed by informant to be Yeheskel Carmel, Israeli Consul General, Los Angeles, California, that "that Senator from the State of Washington" will be in Las Vegas, Nevada the evening of May 24, 1971 and wants to meet some of the local Jewish leaders at a dinner that night. [Eiran] suggested that [Carmel] get in touch with Hank Greenspun, in Las Vegas, in order to arrange something, but nothing "fancy". [Carmel] suggested a \$50.00 a plate dinner and [Eiran] said he would leave this up to them, but said he, [Eiran] wanted to be advised of the final plans. (S) (X)
