An informant, who has furnished reliable information in the past, advised on April 6, 1959, that he learned from Sumner J. Glimcher that Glimcher is the President of International Transmissions, Incorporated According to Glimcher, ITI has been supplying direct news broadcasts from all over the world to a number of radio and television stations in the United Since last fall, Glimcher has been trying to gets proper accreditation from the Soviet Union so that Miss Priscilla Johnson, a resident of Moscow, could broadcast for ITI. \\

According to the informant, Glimcher recently contacted the Soviet Embassy in Washington, D. C., and requested the intercession of Soviet Embassy officials in regard to the accreditation of Miss Johnson. Glimcher stated that Yuri I Permogorov, who represents Radio Moscow in New York could be contacted for further details

Glimcher's address is known to the informant as International Transmissions, Incorporated, 480 Lexington Avenue, New York, New York.

Information received from Immigration and Naturalization Service (INS), New York City (s) on November 27, 1956, reflected that Yuri I. Permogorov arrived in the United States on November 26, 1956 at New York City. INS records reflected Permogorov's Occupation as Correspondent for Moscow Radio, Union of Soviet Socialist Republics in New York City.
