By airtel, 4/5/61, Miami advised that on 4/4/61, an attempted interview with JOE SONKEN, owner of the Gold Coast Restaurant and associate of GABRIEL MANNARINO, was unsuccessful because of SONKEN's completely uncooperative attitude.

On 4/6/61, PG 581-C advised SA NORMAN T. THOMPSON as follows:

On that date, KELLY MANNARINO and NATE FARBER (former Pittsburgh Top Hoodlum), accompanied by a young blonde, unidentified WMA, visited the offices of Associated Theaters, Inc., 76 Van Braam St., Pittsburgh. They were there to discuss leasing arrangements for the Family Outdoor Theater, Leechburg Road, Lower Burrell Township, Westmoreland County, Pa. This theater was originally owned by KELLY and SAM MANNARINO and was sold to NATE FARBER who leases it to Associated Theaters, Inc. It was indicated that MANNARINO, FARBER and the unknown WMA were occupying a suite at the Pittsburgher Hotel, Pittsburgh, and FARBER's Miami, Florida, telephone was set out as UN 6-6075.

On 4/6/61, JOE DUDDY, Manager, Pittsburgher Hotel, advised that NATE FARBER checked out of the hotel on that date and
