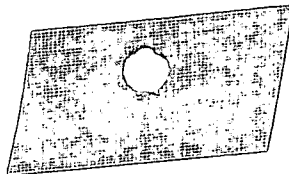

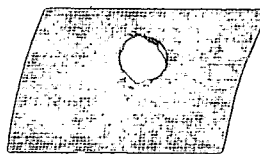

On 5/18/61, PG 615-C advised SA THOMAS G. FORSYTH, III, as follows:

At 1:00 PM on 5/18/61, SAM MANNARINO; WILLIE SAMS, the MANNARINO numbers and sports betting chief; VICTOR STANZIANO, New Kensington, Pa., building contractor, recently associated with SAM and GABRIEL MANNARINO in a proposed housing development, and one LOU LNU, from Philadelphia, met for lunch at the Bonfire Restaurant, actually but not nominally owned by SAM MANNARINO. This restaurant is located on Route 56, Leechburg Rd., Allegheny Township, Westmoreland County, Pa. Their purpose in meeting was to discuss the possible purchase of Allegheny Steel CO., a small fabricating plant in Springdale, Pa., which is in financial distress. They did not seem so much interested in the company's products and machinery as they were in the building and the land. LOU (LNU), from Philadelphia, had been asked to come with MANNARINO, SAMS and STANZIANO, for his professional advise in appraising the plant.

LOU, from Philadelphia, is described as white, male, American, age 61, 5'10", 170 pounds, medium build, full head of white hair, wears
