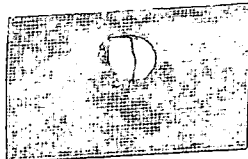
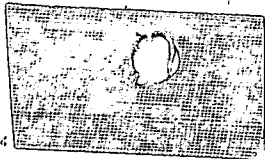
On 6/26/61, PG 615-C advised SA THOMAS G. FORSYTH, III as follows:

The imminent incarceration of the convicted defendants in the "GUN CASE (STUART SUTOR, ET AL; TGP, ITSP; PFA, NM; CONSPIRACY)" has caused some consternation in the MANNARINO mob leadership. On Saturday, 6/24/61, SAM MANNARINO, while at the Bonfire Restaurant near Leechburg, Pa., said that it was a real blow to lose NORMAN ROHMAN, Miami, Fla., who is a top-flight Cuban contact man; JOSEPH RED GIORDANO of New Kensington, Pa., who is a first-rate fence, and even DANIEL "SPEEDO" HANNA of Arnold, Pa., who is very efficient as a gambling dealer and 'strong arm' enforcer collector. MANNARINO said the loss of these men would create some hard-to-fill openings. For instance, to take HANNA's place, two men were considered so far, JOE HORGAN and AL SPISANO, both of New Kensington, but while either man would make a fair dealer, neither was physically or mentally considered for strong arm work.
