A neighborhood source has advised that ROSSELLI was observed by her during the past week at his residence, Glen Towers. Source said that she also observed the red-haired girl (KATHY HORDEN) with ROSSELLI, and source believes that this girl is living at ROSSELLI's apartment. Source also recalled that on one occasion last week she saw ROSSELLI leave the apartment in the company of IRVING LEFF and a man named ROTH who frequently calls ROSSELLI. IRVING LEFF is a part owner of the Hotel Last Frontier Corporation, and a friend of ROSSELLI. ROTH may be JULES ROTH, head of the Hollywood Cemetery Association, who had lunch with ROSSELLI on 4/8/64, at Perino's Restaurant.

It is recalled that on the evening of 5/6/64, ROSSELLI was observed in Los Angeles, riding in a new Pontiac automobile, with a woman, and that the car bore Nevada license plates CF 9679. On 5/11/64, the Las Vegas Office advised that the records of the Nevada Highway Patrol reflect that this license is listed to a 1964 Pontiac, two-door hardtop, registered to K. HORDEN, 2908 Burton, Las Vegas, Nevada.

LV 129-PC furnished information on 5/12/64, that ROSSELLI had actually departed from the Desert Inn Hotel on Wednesday, 5/6/64, but that the registration card at the hotel was not removed until 5/10/64.

Los Angeles airtel to the Bureau of 5/4/64, set forth that on 3/11/64, a \$5000 check payable to ROSSELLI and drawn on the account of INES CHAPMAN, Beverly Hills, California, was deposited to an account maintained at the Union Bank, Los Angeles, by EMANUEL ROTHMAN, ROSSELLI's accountant.

Records of the Bank of America, Beverly-Wilshire Branch, Beverly Hills, California, reflect that INES CHAPMAN opened an account at this bank on 10/17/63, with a deposit of \$4121.42, and furnished her address as 190 North Crescent Drive, Beverly Hills, and her telephone number as 271-4175. She claimed birth in Mexico, and stated that her mother's maiden name was GUADALUPE. When she opened the account, she authorized IRWIN SPIVEY, 170 North Crescent Drive, Beverly Hills, to sign checks on her account. One such check was dated 4/27/64, in the amount of \$446.00, payable to Brand Lease Plan, 2691 Crenshaw Boulevard, Los Angeles, California. The account further reflected that on 3/12/64, a deposit of \$5000 was made to her account and that this was a check drawn on the Union Bank, 8th and Hill, Los Angeles, California. The bank will obtain a photograph of this check in the near future.

The files of the Los Angeles Office reflect that in 1954 and 1955, INES CHAPMAN, aka., was a subject with a number of others in an ITSP case of which the San Diego Office was origin. This case involved a number of shoplifters who allegedly stole from stores in the Los Angeles and San Diego areas, and then the stolen merchandise was sold in Mexico. No prosecution was authorized.

The records of the Pasadena Police Department reflect that on 4/21/48, MARIA DE LA LUZ OROZCO (allegedly identical with INES CHAPMAN) was arrested for petty theft, and forfeited \$100 bail. She claimed birth in Mexico City, in April, 1919.

LA 4268-C advised on 2/14/63, that IRWIN SPIVEY is employed in a stockbroker's office in Beverly Hills, California, and on that date placed a long distance telephone call to LOUIS LEDERER in Chicago, Illinois, from the Friar's Club in Beverly Hills. LEDERER is a close friend of ROSSELLI. On other occasions, this informant furnished information that SPIVEY is frequently at the Friar's Club in Beverly Hills, California.
