ROSSELLI arrived Los Angeles from Las Vegas via air at 1:45 p.m. on 5/16/63. He was accompanied by MORRIE SUESS, a movie director, SUESS was on the same plane with ROSSELLI on 5/12/63 when ROSSELLI went to Las Vegas.

ROSSELLI rented Hertz Corporation car on 5/16/63 at airport and indicated he would return the car Monday 5/20/63. This car parked at ROSSELLI's Los Angeles apartment last night. FISUR revealed ROSSELLI left his apartment on 5/17/63 in this car at about 1:00 p.m. Los Angeles 4396-C\* indicated ROSSELLI was going to Beverly Hills.

LA 4396-C\* advised on 5/17/63 that ROSSELLI was out late last night with SALLY PARKER and "JACK" - identity these persons not known.

CSLA 4333-C furnished information on 5/16/63 that ~~JUDITH CAMPBELL~~, friend of ROSSELLI and of SAM GIANCANA of Chicago, has new residence and telephone number CR 5-7201.

CSLA 4178-S advised this number listed to ~~JUDITH CAMPBELL~~ VON IMMOOR, apartment two at 660 North Doheny Drive, Los Angeles. VON IMMOOR is CAMPBELL's maiden name. JUDITH, according to newspaper columnist, HARRISON CARROLL, is currently keeping company with ~~EDDIE FISHER~~, well known entertainer. CALIF
