ROSSELLI returned Hertz Corporation rental car at Los Angeles International Airport at 6:00 p.m. on 5/21/63. He departed Los Angeles for Las Vegas at 6:30 p.m. via Western Air Lines.

According to neighborhood sources and LA 4396-C*, ROSSELLI returned to Los Angeles on 5/23/63, apparently having driven from Las Vegas in his own 1963 Thunderbird, as this car has been in Las Vegas and was at his Los Angeles apartment garage on the evening of 5/23/63.

LA 4396-C* advised ROSSELLI at his Los Angeles apartment on 5/24/63, but no other pertinent information furnished.

On 5/23/63, LA 4448-PC advised he has known ROSSELLI since about 1923; that he and ROSSELLI are distant relatives, their families having come from the same part of Italy and that it is his understanding that ROSSELLI was born in the United States.

He said he has not seen ROSSELLI much in recent years as ROSSELLI spends most of his time in Las Vegas, Nevada. It is informant's understanding that ROSSELLI is connected in some way with some hotel in Las Vegas.

Interviews with LA 4448-PC are continuing and efforts will be made to obtain additional information from him concerning ROSSELLI.
