Re Bureau teletype 9/11/64 entitled "COMMUNIST PARTY, USA, COUNTERINTELLIGENCE PROGRAM; INTERNAL SECURITY - CAD HOC OPERATION" (Bufile 100-3-10409).

Re Bureau teletype states CIA has advised that four U. S. representatives were in attendance at a convocation of 150 pro-Chinese Communist militants from throughout the world held in Albania 8/10/64 through 8/26/64. This meeting had for purpose formation of International Communist Movement in support of Chinese Communist position and possible preparation for similar gathering to be held in Peking next year. (u)

CIA states HOMER BATES CHASE, his wife, and JACK SHULMAN were among those U. S. representatives present at this convocation. (u)

NY 4047-S* advised that SUSAN FRANK was "out of town" from 8/12/64 through 8/25/64.

Chicago is requested to inform CG [5908] to remain alert in his meeting with CHASE for any information indicating SUSAN H. FRANK, aka Sue Warren, was the fourth U. S. representative at the convocation in Albania. (u)
