Enclosed for the Bureau are six, and CG, PH, and LA one copy each of an LHM, dated and captioned as above.

NY T-1 and NY T-2 are knowledgeable sources in a position to have information of that type.

The LHM is classified "Confidential" as information from NY T-2 is so classified.

On November 11, 1971, Special Branch, Royal Hong Kong Police advised subject arrived in Hong Kong from Los Angeles on September 24, 1971, and departed Hong Kong for Canton, China on September 28, 1971. He returned to Hong Kong on October 22, 1971, and departed Hong Kong for Tokyo on October 23, 1971. (S)

RCMP, on December 8, 1971, advised subject arrived in Ottawa via Eastern Airlines flight 177 from the US on September 17, 1971, and visited the PRC Embassy. He departed Ottawa on the same date via Air Canada flight number 459 for Toronto. (S)

The above information was not included in the LHM as (S) SB information contained restriction of no foreign dissemination without consent of original source and RCMP information was not to be disseminated without prior authority. (S)

On April 14, 1972, James Kenny, Pan American Airways (PAA), New York, New York, advised Richard C. Frank, on September 7, 1971, purchased PAA ticket number 026145254874, for travel from New York to London via flight 102Y, departing New York 9:00 PM, September 15, 1971. A copy of the ticket reflected it had been utilized on the above-mentioned date.

NY T-1, who has furnished reliable information in the past, advised Frank apparently had been in Los Angeles, California, on or around September 17 and 22, 1971, and was probably lodged at the Sheraton Inn of Los Angeles on September 17, and at the Chateau Marmont Hotel on September 22, 1971.

NY T-2, a confidential source abroad, advised Frank entered the People's Republic of China on September 29, 1971. (S)
