On 6/28/65, PEDRO FERNANDO ENTENZA ESCOSAR, PSI - Under Development (Protect by request and characterize as having been contact insufficient number of times to establish reliability) advised SA JOHN G. GOEDTEL as follows:

Captioned organization to hold two day meeting in Tampa, Fla. Will commence 2:30 p.m., Saturday, 7/3/65, and end Sunday 7/4/65. Each delegation throughout U. S. to be represented by "official" delegate and two members local chapter. Foreign delegations also expected. Source's optimistic estimate of number of people to be present is 100. Source who is "official" delegate of Wash., D.C. Chapter will possibly be accompanied by two others not yet identified. Source will depart Wash., D. C., Friday 7/2/65.

Conference will be concerned with "broadening and explaining of 'Declaration of Principle' of 1962" as well as revisions in internal administrative structure of organization.
