It is also requested that the Bureau point out to the Legat, Paris, that it was reliably reported that in September, 1963, the subject contacted TANG Ming-chou in London and that it has also been reported that TANG is in charge of political intelligence for the People's Republic of China as it pertains to English speaking countries.
