On 1/18/66, GUIDO CAPOLINO was interviewed by SAS of the NYO.

CAPOLINO advised that he is in the process of moving his company, Jomar Lathing Corporation, to 349 Vassar Road, Poughkeepsie, NY. He further advised that his brother, ILANDO, President of Capolino and Sons, is also moving to Beacon, NY. ILANDO will be changing his company's name to Challange Building and Design Corporation at 143 Main Street, Beacon, NY.

CAPOLINO advised that the reason for he and ILANDO leaving the NYC area was to get away from the difficult labor situation in NYC and struggle to compete with larger construction companies.

CAPOLINO indicated no illegal pressures by labor unions were used and he had no actual knowledge of "shake-downs" or "payoffs" in the construction field, although he has heard that it is happening.

CAPOLINO did not deny that a "Mafia" existed, but felt that it has been "blown-up" out of proportion. He stated that many people use this name to scare others, even though the individual has no connection with any organized criminal group. CAPOLINO denied any actual first hand knolwedge and declined to discuss the matter on the basis of having no actual knowledge.

In the CAPOLINO apartment numerous hunting rifles were displayed in racks. The topic of hunting was mentioned by the SAS and CAPOLINO voluntarily stated that he was hunting in Canada during the Fall of 1965. He did not, however, comment on who he was with and it was felt that the SAS should not indicate any knowledge of CAPOLINO's activities as reported by the RCMP.

CAPOLINO indicated a willingness to contact the FBI should he be confronted with any illegal pressures in his new location. He further advised that two of his brothers would be remaining in the NYC area in the construction field and before he left the area, he would talk to his brothers and advise them of the interest of the FBI and assistance which can be obtained if the brothers are confronted by illegal pressures by any labor unions or other persons.
