ARTIME IS NOW FURNISHING INFORMATION RELATIVE TO THE REFERENCED MATTER. HE HAS AGREED TO FURNISH ADDITIONAL INFORMATION AND WILL BE HANDLED BY SA SINECIO GUTIERREZ, HE IS PRACTICING AS A CONSULTANT IN PSYCHIATRY AT MT. SINAI HOSPITAL, MIAMI BEACH, FLORIDA. HOWEVER, HE WILL ALSO FURNISH INFORMATION CONCERNING CURRENT ANTI-CASTRO ACTIVITIES PRINCIPALLY EMANATING OUT OF THE MIAMI, FLORIDA AREA, CURRENTLY CENTERING AROUND THE "CORU", THE ANTI -CASTRO TERRORIST ORGANIZATION, NEWLY FORMED IN THE DOMINICAN REPUBLIC, HEADED BY DR.
