Review of references on the subject's name and variations, as well as review of file of persons believed to be associates of the subject, failed to reflect any additional information regarding his identity or membership in any organized criminal element.

Inasmuch as the NYO is unable to place the subject in "La Causa Nostra" or any organized criminal element, and also is unable to fully identify him, this case is being closed by the NYO, UACB.

In the event information is developed through other investigations which fully identifies TARTAGLIA, this case will be re-opened in the NYO and investigation will be conducted in accordance with the Criminal Intelligence Program.
