PH-591-C\* was authorized 8/31/60, installed 10/26/60, and activated 10/27/60.

At time of installation, facilities were available for two separate microphones, insofar as bringing the microphones into the central office were concerned. Bureau has been advised in recent communications of the anticipated increase in telephone facilities at the Maggio Cheese Company, 1030 South 11th Street, Philadelphia. This matter has been followed closely.

On 9/14/61, Philadelphia Division contacts at Bell Telephone Company advised that the Maggio Cheese Company has requested an increased telephone facilities of fifty per cent. This will necessitate the installation of an additional PBX and will place two telephones on each desk. In this process, it has also been arranged that an additional pair of wires running from the central office can be obtained with the net result being that two additional microphones can be installed at the present location of PH-591-C\*. This company operated by PETER SALVATORE and MARIO MAGGIO, each having separate offices. Present coverage affords coverage only to PETER MAGGIO's office.

The increased coverage would afford coverage to all three offices and should result in increased intelligence and general info re captioned subject.

Technically, the installations will have to be installed using altered 44A blocks which will have to be installed under pretext during the process of increasing the Maggio Company's present facilities. This was the method used in first installation and complete security can be obtained again in the present installation. It is thereby requested that the Bureau authorize this increased installation and that the Lab, Electronics Section, furnish the Philadelphia Division two altered 44A blocks.

For Bureau info, it is noted that the telephone company is beginning instant installation during the coming week and Philadelphia, at this time, can furnish no specific date that the opportunity will arise to increase activities of PH-591-C\*. Philadelphia Division, however, has to be in the position to move when the opportunity presents itself, and it is thereby requested that this matter be expedited and that the altered 44A blocks, if Bureau permission is obtained, be forwarded to reach the Philadelphia Division no later than Wednesday, 9/20/61.
