

On page 7 POYLE mentions MIGUEL ENCISO as being the Captain Pilot with the Cubana Airlines who has carried his letters out of Cuba for him. Miami believes this individual is identical to MIGUEL ENCISO SIGLE, Bureau file 134-10414.

CIA, Miami, was contacted regarding the information contained in the enclosed communication and they advised they have not taken any action concerning the above individuals who might possibly attempt to enter the United States, other than notify the "interview group" at Opa Locka Detention Center, Opa Locak, Florida. If these persons do enter the United States they will be thoroughly screened by INS and CIA.

The inclosed in this letter the name of my friend Miniso. I also meant of mention that the name he goes by, in the organization he works with is:

I will last week when he was in Mexico there was a message there for him he was are very hot here, especially since BLANCO had been arrested, I wat wanted to mention to you, that this man is not afraid of taking any barness, but that he wants to be quiet for a while, until he is sure that hings are not too hot for him. I refuse to let him carry any messages for a while, so therefore this letter will be mailed to you thru another to for a while, with the assurance that this letter will not be tampered with in cuba in any way at all, as the person carrying this letter cannot be searched in any way at all, also he does not know what my letter contains, as he does not know me at all, and does not know that this is my letter. As long as I have mentioned the name of ENSISO, I am afraid to let him carry this letter because if he were searched before leaving on his flight, and they saw his name linked in any way at all, you know what the outcome would be, and I don't want to have that on my concience. I don't mind risking my own and I don't want to have that on my concience. I don't mind risking my own life, but don't feel that I have the right to risk his life, just because he is ready to help me in any way. I am sure that you understand this.

I have helm at him as much as I can when he has asked me to get certain information for him, and would not hesitate to do anything in the world for him, in my power. He has a ham raddo setup here that he operates with a Gov't license. I know this man's complete background, and can only say that he is the most honest man I have ever in my life met, and there is nothing in the world he would not do for a friend, especially in risking his own life to do it. At times Thave had to criticize him as he had wanted to take too many chances with things, but I feel proud of the fact that he does listen to me. I think that this is the information you want, if not please advise me otherwise. This is the ONLY MAN THAT CARRIES LETTERS FOR ME.
