Re Tampa letter to the Bureau 8/24/66.

Enclosed are 9 copies of an LHM, dated and captioned as above. Two copies of LHM are enclosed for Tampa. One copy is being disseminated locally to INS, Miami.

MM T-1 is [HARRY RANDALL,] CIA Covert, Miami (protect) who furnished information to SA JAMES D. HAYES.

Interview of JOSE VILLALOBOS OLIVERA was conducted by SAs JAMES D. HAYES and MAURICE F. FARABEE, of HECTOR PEREZ NUNEZ by SAs CLARENCE P. GRAHAM and MAURICE F. FARABEE. Otherwise investigation was conducted by SA FARABEE.

Referenced Tampa letter indicates interview of subject was temporarily being held in abeyance pending a determination whether he is involved in the investigation of Tampa file [105-632] in case entitled [ANTONIO MARCOS CACERES,] aka [IS - CUBA.] [CACERES] during a recent trip to Cuba [received certain training by Cuban intelligence] and was told he might [be contacted by one EDUARDO.] Even though subject DIAZ was allegedly in the employ of Cuban intelligence at one time, it is the belief of the Miami Office that interview of him would in no way jeopardize Tampa's investigation of [ANTONIO CACERES or his operation as a double agent.] Past experience has indicated that CIS usually uses pseudonyms for its intelligence agents.

Tampa Division will advise Miami if that office still objects to requesting Bureau authorization to interview subject.
