Reurtel 4/1/63 captioned "Unsub, Bombing of Residence of Maria Balbuena; 912 Southwest 5th Avenue, Miami, Florida, March 31, 1963; Bombing Matters."

Department has been advised of bombing; however, inasmuch as local law enforcement authorities have not requested Bureau investigation, the Department has requested no investigation at this time. Miami should make certain, however, any information developed by local authorities of possible interest to Government agencies is furnished your office. Submit any such data to Bureau in form suitable for dissemination. Should any information be developed indicating bombing was foreign directed or planned, same should be immediately furnished Bureau, together with details of action being taken by your office.

Miami is instructed to interview Maria Balbuena for purpose of obtaining detailed information regarding the Committee to Rescue Cubans from Cuba, including the identities of its officers and membership and purpose of organization. You should ascertain its method of operation and details of financing. Identities of any contacts in Cuba utilized by the organization should be determined, as well as methods of communication with these individuals. Through sources and informants determine organization's importance and influence in overall anti-Castro activities in U.S.

You should interview Luis Balbuena for purpose of obtaining any information in his possession regarding the identities and activities of any individuals connected with the L-66 organization. Any data obtained regarding L-66 should be furnished Bureau under appropriate caption in form suitable for dissemination.

With regard to Luis Balbuena, Miami refer to your airtel and letterhead memorandum dated 3/19 and 25/63 captioned "Haitian Revolutionary Activities; IS - Haiti." Miami should be alert for any information that bombing was reprisal action against Balbuena due to his furnishing information regarding alleged plot to overthrow government of President Duvalier of Haiti. *24*
