Re Newark airtel to Bureau, dated 10/1/74.

On 10/24/74, NK 5006-s advised that MANOLO RAY, due to job commitments, could not make the meeting in Miami referred to in referenced airtel. For this reason, this conference was suspended. (X) (U)

RAY is now in Jamaica on business. At the conclusion of this business, he is planning to travel to Venezuela with TONY SANTIAGO of Miami and ANGEL LARRAMENDI of the New York New Jersey area. These three persons, accompanied by ORLANDRO CASTRO of the PRP in Venezuela, plan to see president CARLOS ANDRES PEREZ of Venezuela before the Organization of American States (OAS) conference in Quito, Ecuador. The purpose of this trip is to persuade the president to insure that Russia removes all troops from Cuba before selling oil to Cuba. (X) (U)

The PRP will then hold a similar conference in Miami sometime after the OAS conference. (X) (U)
