The subject also stated in her letter that since her trip was in connection with "professional work" which required her presence in London on September 13, 1963, and since that has been rendered impossible by the delay, she no longer needed the passport.

Mr. BROOKS stated that in view of the above, the Passport Office would refund to the subject the fee she paid at the time of her passport application.

The subject's husband, RICHARD C. FRANK was observed by Special Agents of the FBI to board BOACC Flight 506, for London, on September 13, 1963, which flight was due to arrive in London at 9:30 apm., September 14, 1963.

NY T-19 advised on October 8, 1963, that on September 11, 1963, the subject or her husband, RICHARD C. FRANK, attempted to contact one PEGGY PINCKHERD, Number 3, Heathview, Gordon House Road, London, England, to state that one of them would arrive in London on the following Saturday.

NY T-15, a confidential source abroad, advised on November 18, 1963, that PEGGY PINCKHERD is presumably identical with PEGGY PINCKHERD whose true name is MARGARET MARY JOAN AGNES RINCKHERD, uusually known as Mrs. PEGGY PINCKHERD, residence 3 Heathview Gordon House Road, Kentish Town, London, N.W. 5, England. According to NY T-15, PINCKHERD is a fairly long-standing member of the CP who has held in her time a number of minor Party posts at branch level. She visited Peking for a month in October/November, 1952, for the Peking Peace Conference, and has been active in the British-China Friendship Association since that time. Her husband, REGINALD ARTHUM PINCKHERD also has a long record of CP membership.
