On 1/28/64, CS WF 1401-S (protect, who has furnished reliable information in the past) advised SA WILLIAM D. CAMPBELL that telephone numbers WI 8-5380, 5381 and 5382 were nonpublished numbers for Centaur Enterprises, Shady Grove Road, Gaithersburg, Maryland. These numbers were connected on 4/29/63 and discontinued on 6/7/63.
