The source utilized in my letter to the Director of the Bureau of Intelligence and Research, Department of State, dated September 19, 1963, is unavailable to testify at an administrative hearing.

The source identified as T-4 in the memorandum dated September 10, 1963, at New York, New York, is unavailable to testify at an administrative hearing.

The sources identified as T-6 and T-9 in the report of Special Agent Daniel A. Flynn, dated July 2, 1963, at New York, New York, and the source identified as T-15 in the report of Special Agent Reidy, dated November 25, 1959, at New York, New York, are former sources of this Bureau. An inquiry has been directed to the New York City Office of this Bureau and you will be promptly advised as to whether these three former sources can be made available to testify at an administrative hearing.

NOTE:

Subject is on Security Index and during 1959-1960 spent approximately 18 months in Communist China. Subject is in close contact with owners of "China Daily News," a pro-Chinese communist language newspaper published in New York City. Subject has allegedly been in contact with Chinese communists in New York City. State Department advises subject applied for a passport on 2/18/64 and State Department desires to obtain witnesses who could testify at an administrative hearing regarding her possible Communist Party membership in order that State Department could sustain the denial of a passport to the subject. Sources mentioned above who are not available for testimony are our highly placed informants, CG 5824-S*, NY 559-S* and BA 975-S* as well as a confidential investigative technique. New York, by separate communication being instructed to determine the availability and willingness to testify of
