PH 623-C\* advised that ANGELO BRUNO and close La Cosa Nostra associate FRANK NICOLETTI spoke privately for several minutes on 3/27/64 during which the following was obtained:

A.B. Frank, I should have stayed in Italy when I went there, you know last March. I should have stayed for about a year.

F.N. It is...to do favors... make money out of it. You do it for favors and let yourself a ... look for a little percentage somewhere.

A.B. Let's see up to now there is probably...they could give me up to fifteen years on that, so they will probably give me eleven or something like that...

F.N. You mean in your case?

A.B. Yeah. So fifteen and fifty...I'll be almost as old as Mr. Migo (ANTONIO POLLINA), probably when I get out of there.
