Further enquiries regarding Michel POZZA indicate that he returned to Canada again on 13 MAR 67, at which time he imported a new Mustang convertible which he purchased in the U.S. on 18 JAN 67 and on which he paid taxes and duties to Canadian Customs in Montreal, amounting to \$859.21. The Customs declaration did not indicate the location where this vehicle was acquired, however, the vehicle bore current California licence TWS 473, registered to Michel POZZA of 400 North Martel, Los Angeles, California.

2. It is requested that the Los Angeles address be checked out to ascertain the registered owner of the property and their connection, if any, with POZZA or any other criminal element.
