Vera said the JGCE is now inactive, and Sierra has returned to Chicago, Illinois

FLORIDA

On January 21, 1964, MM T-1 who has been involved in Cuban revolutionary activities for the past four years, advised that the JGCE has had no activity since about November, 1963; the organization no longer exists; and, Sierra has returned to Chicago, Illinois.
