MESSAGE TO TELEPHONE AL MARSHAL AT THE ESSEX HOUSE, NYC.

INFORMANT CONTACTED MARSHAL AND LEARNED THAT MARSHAL IN
DALLAS HAD AGREED WITH DALLAS LA COSA NOSTRA (LCN) BOSS JOSEPH
CIVELLO TO OBTAIN TEAMSTER FINANCING THROUGH A SOURCE OTHER THAN
KANSAS CITY BOSS NICK CIVELLA. MARSHAL TOLD INFORMANT THAT
CIVELLO SPOKE WITH LITTLE JOE (LNU) AND ARRANGED FOR MARSHAL TO
MEET WITH HIM IN DALLAS, TEXAS. LITTLE JOE'S FULL IDENTITY NOT
GIVEN TO INFORMANT. MARSHAL ADVISED THAT HE AND LITTLE JOE

WERE CURRENTLY IN NYC AND INTENDED TO PERSONALLY INTRODUCE INFORMANT TO MR. R. P., THE TOP MAN IN NYC. MARSHAL ADVISED THAT THROUGH R. P. THEY WOULD BE INTRODUCED TO THE SUCCESSOR TO TEAMSTER BOSS JAMES HOFFA THROUGH WHOM FINANCING COULD BE OBTAINED.

MARSHAL ADVISED THAT THEY WOULD TELEPHONICALLY CONTACT INFORMANT WHEN THE MEETING WITH R. P. WAS ARRANGED AND, THEREAFTER, INFORMANT WOULD FLY TO NYC.

INFORMANT WILL ADVISE WHEN MESSAGE RECEIVED AND EXACT DATE FOR APPOINTMENT MADE BUT ANTICIPATES TRAVEL WILL BE MADE FRIDAY NEXT.

INFORMANT ADVISED HE LEARNED THROUGH CONTACT WITH MARSHAL THAT THERE HAD BEEN A MISUNDERSTANDING AND THAT NICK CIVELLA HAD NOT TRAVELED TO DALLAS BUT THAT MARSHAL IN CONVERSATIONS WITH CIVELLO HAD DECIDED A BETTER METHOD OF HANDLING WAS AS CURRENTLY SET FORTH ABOVE.

IT IS NOTED THAT INFORMANT IN EARLY SIXTYSEVEN SUCCESSFULLY DEFENDED NEPHEW OF PITTSBURGH LCN BOSS JOHN LA ROCCA WHO WAS CHARGED IN LOS ANGELES WITH MURDER. DUE TO THIS, LA ROCCA'S NEPHEW, ANTHONY LA ROCCA, JR., INDICATED HE WOULD LIKE TO INTRODUCE HIM TO HIS UNCLE IF EVER IN THE AREA.

INFORMANT OF OPINION THAT HE CAN SUCCESSFULLY LEARN IDENTITIES OF INDIVIDUALS WHOM HE CONTACTS. THEREFORE, LOS ANGELES RECOMMENDS THAT NO COVERAGE BE AFFORDED INFORMANT MEETS IN NYC AND PITTSBURGH.

ALL OFFICES WILL BE KEPT ADVISED OF ALL DEVELOPMENTS IN THIS MATTER.
