Re Tampa letter to Bureau dated 4/7/67.

Local headquarters for captioned anti-Castro organization continues to be at 1515 Tenth Avenue, Tampa, Florida. This address is the home of ENRIQUE SOMEILLAN who continues to serve as Coordinator of MIRR in Tampa. Continued contact with Cuban sources in Tampa, including TP 52-S, has failed to reflect any organized activity or regularity of meetings on the part of captioned organization.

On April 4, 1967, TP 52-S advised that ENRIQUE SOMEILLAN continues to serve as Coordinator of MIRR and that MIRR has no planned activity in view of lack of organization among the Cuban exiles in Tampa. He advised the Tampa unit of MIRR is primarily interested in propaganda keeping the Cuban people in this country and in Cuba aware of a movement interested in the overthrow of FIDEL CASTRO and his communist government.
