[On 6/21/67, PSI CARLOS DE LA VEGA] advised that MIRR representatives in New Orleans are MANUEL GIL and Dr. GARCIA FONT. The New Orleans activities of MIRR are confined to collection of contributions.

Source advised that the wife of ORLANDO BOSCH AVILA is affiliated with the Tulane University Medical School and resides in New Orleans, in the Parkchester Apartments. Source last saw BOSCH in February, 1967, however it was rumored that BOSCH was in New Orleans, approximately three weeks ago.

Base on this organizations lack of activity in the New Orleans area, this case is being closed pending additional developments.
