A Confidential Source, who has furnished reliable information in the past, reported in New York City on June 5, 1967, that a meeting took place on June 3-4, 1967, between IGNACIO NOVO, Secretary General of the Movimiento Nacionalista Cubana (Cuban Nationalist Movement - CNM), his brother, GUILLERMO NOVO, both of the New York City - Newark area, and Dr. ORLANDO BOSCH, head of the MIRR. The Confidential Source said that future plans of anti-CASTRO Cubans were discussed. These plans centered in Canada. (S)(M)

According to the Confidential Source, BOSCH wanted to carry out a two-pronged attack against the Cuban Government in Canada. He specifically spoke about the assassination of the Cuban Ambassador to Canada, and an attack on a Cuban ship in the Port of Montreal, Canada. (S)(M)

BOSCH said they would not use a member of the CNM because they were too "hot". He stated that his man "GUTIERREZ" in Miami had nine rockets, timing devices, and C-3 and C-4 (explosives) which could be used in their (S)(M)
