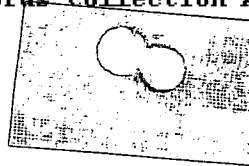

DAILY SUMMARY.

PH 614 CTE ADVISED BRUNO VISITED JULY 26 BY SAM RANGATORE OF BUFFALO. SAM AND DAUGHTER STAYED AT BRUNO HOME. WILL BE AT JEAN BRUNO'S WEDDING AUGUST 26, BUT WILL NOT RECEIVE INVITATION BY MAIL, INDICATING SAM IS AMICO NOSTRO.

CALOGERO SINATRA, ITALIAN NATIONAL, AT PENN JERSEY VENDING CO. THURSDAY, JULY 26.

BRUNO HAD LONG VISIT AT PENN JERSEY WITH JOHN CAPELLA, PHILADELPHIA GROCER, BROTHER-IN-LAW PETE CASELLA, WHO IS NOW SERVING 40 YEARS IN USP, ATLANTA, FOR NARCOTICS VIOLATIONS. BRUNO TOLD CAPELLA LULU ESPOSITO TOOK OVER ZIGANETTE GAME FROM SONNY RICCOBENE BECAUSE LULU PAYS PROTECTION, SONNY DIDN'T.

PH 614 CTE MADE AVAILABLE 62 ADDITIONAL NAMES PERSONS TO WHOM WEDDING INVITATIONS HAD CARRIED. MANY LAST NAMES ON THIS LIST, WHICH INCLUDES APPROXIMATELY 10 MEMBERS JEWISH MOB. MAIL COPY TO BUFFALO.
