Enclosed for San Juan is a copy of a report furnished
by MM 815-OA on 6/2/77. (X)

Miami indices reflect numerous references for subject.
Most of the information contained in the corresponding files
for these references is in the possession of San Juan.

Sources knowledgeable in Cuban exile matters were
contacted regarding subject and the following information was
obtained. Although the information, including the lengthy
data contained in enclosed report is not considered to
be current information, it is being forwarded to San Juan
for information purposes:

On 5/18/77, MM 3945-C advised that RAY-RIVERA
was the Minister of Public Works in Cuba under FIDEL CASTRO.
He was also a member of the 26th of July Movement with
FIDEL CASTRO. He was one of the founders of "Movimiento de
Recuperacion Revolucionario" (MRR) and "El Jure".

His brother was killed while a prisoner in Cuba,
while RAY-RIVERA was last seen in Miami approximately two
years ago.
