METROFF requesting he sign for the bonds, but METROFF declined to do so unless he received authority from his parent company. SILVERMAN called the United Bonding Insurance Company, Indianapolis, Indiana, who in turn called METROFF authorizing him to sign for the bonds.

According to MI 686-C, MEIROFF received no payment for signing for the two \$10,000 bonds, but was paid \$1,000 in cash by ANTHONY "SHERIFF" CEFALU, known Milwaukee hoodlum bookmaker, to cover the previous amount owed to him by DI MAGGIO's brother.
