On 5/23/68, NY 4336-C-TE advised that VITO GENOVESE had issued orders to both the BONANNO and SCIACCA faction of the PAUL SCIACCA "family" to terminate their gangland war until he was released from prison or resolved the dispute himself from within the prison.

Informant stated that GENOVESE has instructed BONANNO to keep himself and his son, as well as certain potential troublemakers of the BONANNO faction, out of NY and to remain "out West" until the dispute is settled.

Informant pointed out that GENOVESE has always wielded considerable influence over JOE BONANNO and expects BONANNO to acquiesce to GENOVESE's orders.

Informant stated that he expects the SCIACCA faction also to honor GENOVESE's instructions, however, stated that FRANKIE "T" MARI is highly displeased with the GENOVESE ordered truce.
