As the Bureau is aware, LA 4448-C-TE is a member informant of extreme value to the Los Angeles Office and the Bureau concerning information of importance to the Criminal Intelligence Program and, in particular, concerning the activities of LCN both on a national and a local basis.

LA 4711-C-TE, while not an Italian is extremely close to LCN leadership in the Los Angeles area and as been a close confidant of LCN leaders for many years. The primary source of income derived by the LCN in the Los Angeles area is either made as a result or due to the activities of LA 4711-C-TE.

LA 4711-C-TE, on 5/24/68, reported the following information which was learned by him several days prior in a conversation he had with LCN Boss NICOLO LICATA.

LICATA, in general conversation concerning LCN investments without any prelude, warned this informant to stay away from and not have anything to do with LA 4448-C-TE because this individual, according to LICATA, was an informant for the FBI. LICATA did not explain nor did he give any

indication that any ramifications would result or that there was any danger to the life of LA 4448-C-TE, but, according to informant, merely made this known to him as a precaution so that he would not have confidential conversations.

The exact detailed significance of the above information is not known to the Los Angeles Division at this time and, based on the above information, contacts with logical informants are being observed closely in an effort to pick up any information which would bring forth the significance of the above conversation.

It is noted that the Agent having contact with LA 4711-C-TE in no way gave any indication when this information was learned that LA 4448-C-TE was a source of the Bureau and in order to protect the identity of this informant, no detailed specific questions were asked. However, the informant volunteered that this was the extent of the information furnished to him and stated that he had no additional information in this regard.

The Bureau will be kept closely advised of any information learned in this regard.
