On October 20, 1961, Subject CURRY appeared in United States District Court at Cleveland, Ohio, and before United States District Judge CHARLES J. MC NAMEE waived prosecution by indictment and consented to plead to an information charging violation of Title 18, Sections 2421, 2422, and 371, United States Code. The information was filed at this time. Judge MC NAMEE then sentenced CURRY to serve two years in the custody of the Attorney General.

Detective ROSS requested that these photographs be shown to REDDEN as well as victims SUSAN MARIE BLACK and JOYCE ANN JANKOWSKI to determine if these individuals are working as prostitutes for PARKS in Toronto.

The victims and subject CURRY when previously interviewed said they had never seen any of the girls working for subject PARKS. Victims had never even heard of any girls he had working for him and the only girl CURRY had heard mentioned was a girl named SIMONE. She previously advised that she had never seen this girl.
