For information Pittsburgh Division, investigation
into this phase of the above captioned subject matter was
initiated on New Orleans Airtel to Bureau 10/31/67, and
the following information in that Airtel is set out for
the Pittsburgh Division:

NO 1242-C advised that between 1:30 and 2:00 PM,
10/30/67, he was at the Italian Import-Export Co., New
Orleans, Louisiana, a business owned by ANTHONY S. CAROLLA
and FRANK GAGLIANO, suspected LCN members. During this
time, ANGELO PALMISANO of New Orleans, who is the brother of
VINCENT JAMES PALMISANO (convicted 10/28/66, at Miami for an
AR - HOBBS ACT violation); CAROLLA, GAGLIANO and four other
individuals, one of whom was known as TONY (LNU) (an employe
of GAGLIANO), JIMMY (LNU) and one man wearing a fancy diamond
encrusted gold belt with the initials "J.P.", appeared.

Source stated that discussion among these individuals
was concerning the stupidity of the "fuzz" and specifically
mentioned was the suspension of Capt. ROLAND CAPPOLA, Troop I,
Louisiana State Police. One individual commented that the
