Re Kansas City airtel to Bureau, 11/15/67, captioned, "KC 586-C-TE, TECIP," and Milwaukee airtel to Bureau, 12/5/67.

Referenced Kansas City airtel set forth info from KC 586-C-TE who identified organizational setup of LCN families in the Milwaukee, Chicago and St. Louis Divisions.

Among the Chicago family, informant mentioned ROSS PRIO and FIFI BUCCIARI as being LCN members. ROSS PRIO is the subject of MI 92-142 and FIORVANTE BUCCIARI is subject of MI 92-278.

It has been determined BUCCIARI maintains a residence at Lake Geneva, Wis. and PRIO visits Williams Bay, Wis. frequently.

Kansas City is requested to question KC 586-C-TE regarding any info re interest PRIO and BUCCIARI may have in Lake Geneva, Wis. area. Of particular interest would be any indication PRIO has financial interest in the new multi-million dollar "Playboy Club," to be opened in Lake Geneva during April, 1968. A Milwaukee source has previously advised PRIO has a considerable investment in this club.
