AS PREVIOUSLY REPORTED RAIDS CONDUCTED BY LOCAL AUTHORITIES, BASED UPON INFORMATION AND EVIDENCE DEVELOPED BY BUFFALO FBI AGENTS ON DEC. FIVE AND DEC. TWENTYTWO, LAST ON DROP LOCATIONS BEING UTILIZED BY LCN BURGLARY RING RESULTED IN RECOVERY OF OVER THREE HUNDRED FIVE THOUSAND DOLLARS IN STOLEN FURS, STERLING SILVER FLATWARE, CIGARETTES, AND ANTIQUES. THIS PROPERTY PROCEEDS OF MAJOR THEFT BURGLARIES WHICH HAVE TAKEN PLACE IN WESTERN NY DURING THE PAST SIX MONTHS.
