Re Bureau airtel to New York, et al, dated 1/12/68; Philadelphia tel to Bureau and SACs Miami and Tampa, captioned "ANGELO BRUNO, aka; AR; OO:PH," dated 1/10/68.

For information of receiving offices, the referenced Philadelphia tel advised that ANGELO BRUNO departed Philadelphia enroute Miami, Fla., on 1/8/68. As of 1/15/68, BRUNO has not returned to Philadelphia.

PH 677-C-TE, a highly reliable source who is in a position several times each week to examine numerous private papers of ANGELO BRUNO, has advised that immediately following BRUNO's departure from Philadelphia, he observed a slip of paper bearing telephone #813-341-2131, which is located in the Tampa, Fla. area. On this same slip of paper appeared the address "201 58th Street, North." Subsequent to BRUNO's departure for Florida, a package arrived at the BRUNO residence postmarked Miami Beach, Fla., which was sent by subject's wife, SUE BRUNO, who accompanied her husband to Miami on 1/8/68.

The above information is being furnished to offices receiving this communication in view of the contents of re Bureau airtel which indicates the possibility that an LCN meeting is to take place in the Miami, Fla. area 1/17-19/68.
