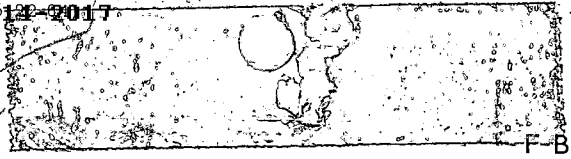

On 1/4/68, NK 1827-C reported that there was to be a meeting of the LCN in Miami, Florida, from 1/17-19/68, which would be attended by many of the old line bosses. He said that the Eden Roc Hotel in Miami, Florida, was the reported meeting place. He also stated that a relative of his, "MIMI" LA MANDRA, formerly of New York City, who now resides in San Diego, California, was reportedly going to be in attendance at this meeting.

Informant is not an LCN member but has been associated for many years with known LCN members in the Newark area and is knowledgeable concerning hoodlum activities. In 1958, he furnished information concerning LA MANDRA's partnership in alcohol and narcotics with LCN member ANTHONY RIELA and SETTIMO ACCARDI.

Informant, who is unable to identify any other participants in the proposed meeting, will attempt to develop further information concerning it.
