Reference is made to our memorandum of December 1, 1959 concerning the leaflet-dropping airplane flight over Havana on October 21, 1959, involving Pedro Luis Diaz Lanz and Frank A. Fiorini.

The Federal Aviation Agency has advised us that the following civil penalties have been imposed on these individuals by reason of this flight in violation of FAA regulations:

1. Diaz Lanz - \$1,000 fine.
2. Frank Fiorini - revocation of pilot certificate by order dated May 26, 1960.

The Federal Aviation Agency also advised that it had accepted the compromise offer of \$1,000 made by Diaz Lanz, payable in four installments of \$250 each, as full settlement of the penalty incurred by him for his alleged violation of the Civil Air Regulations. The settlement with Diaz Lanz does not, of course, become final until full payment is received.

We were further advised that the action against Fiorini has already become final since the time allowed for him to appeal to the Civil Aeronautics Board has expired.
