TO TRANSPORT A LOAD OF ARMS TO CUBA, AND THE BOAT IS NOW BEING REPAIRED. STURGIS CLAIMS HIS GROUP WILL LEAVE MM IN ONE OR TWO WEEKS ON THIS BOAT TO ATTACK CUBA. DURING PAST THREE WEEKS STURGIS HAS RECRUITED ABOUT FIVE AMERICANS FROM GROUPS MAINTAINED BY ROLANDO MASFERRER ROJAS, FORMER CUBAN SENATOR. STURGIS HAS BEEN CONTACTING ANSELMO ALIEGRO, FORMER CUBAN PRIME MINISTER, FOR DONATION OF MONEY TO BUY TWO BOATS TO TRANSPORT THIS GROUP TO CUBA. SO FAR ALIEGRO HAS NOT CONTRIBUTED. LAST WEEK STURGIS MEN WERE HUNGARY AND SOLICITED FOOD DONATIONS FROM CUBAN GROCERY STORES IN MM. STURGIS HAS BEEN SEEN AT DIFFERENT CUBAN HANGOUTS SOLICITING BACKING. MM SIX THREE NINE DASH S CONSIDERS STURGIS A UNRELIABLE BRAGGARD, NOT CAPABLE OF AN EXPEDITION AND WHO DURING THE PAST YEAR HAS CLAIMED HE WOULD ATTACK CUBA IN IMMEDIATE FUTURE. CIA MM SAYS STURGIS IS ON HIS OWN. ALFREDO HERNANDEZ MENTIONED IN RE TEL CONTACTED AT MM TELEPHONE MO FIVE TWO ONE FIVE ONE, AND REQUESTED INTERVIEW BE POSTPONED UNTIL MORNING OF TWELVE SIXTEEN SIXTY.
