tion requested below, there are enclosed 1 copy each of rereps.

[ New York will note that the Department in a letter to  
the Bureau, 7/17/61, stated that in light of activities on the  
part of subject, as well as his past history of extensive  
revolutionary activity, it was the opinion of the Internal Security  
Division that there was sufficient indication of possible viola-  
tions of Title 18, U. S. Code, Section 960, to warrant investiga-  
tion. ] The Bureau by letter 7/20/61 instructed the Miami Office  
that all outstanding investigation should be conducted concerning  
subject, and such additional investigation should be instituted  
to fully develop the recruiting activities of the subject and the  
plans of his "International Brigade" to embark upon an expedition  
against Cuba.
