ON JUNE SEVEN LAST, NK TWO THREE SEVEN SIX-C-TE  
ADVISED ANGELO CARUSO, OF NYC, *NEW YORK CITY* HAS BEEN MADE THE BOSS OF THE  
BONANNO FAMILY. JOSEPH ZICARELLI, TOP NJ HOODLUM, *NEW JERSEY* HAS BEEN  
MADE AN UNDERBOSS IN NJ AND VITO (DE FILIPPO) *NEW JERSEY* HAS BEEN MADE AN  
UNDERBOSS IN NYC. *NEW YORK CITY* SOURCE STATED THAT PAUL SCIACCA, NYC, HAS  
BEEN PLACED "ON THE BOARD".

SOURCE ALSO ADVISED THAT ON MAY TWENTY NINE LAST,  
ZICARELLI MET WITH SAM DE CAVALCANTE, HEAD OF NJ FAMILY OF LCN, *LA COSA NOSTRA*  
IN KENILWORTH, NJ AND LATER SAME DAY ZICARELLI MET WITH ANGELO  
DE CARLO, *LA COSA NOSTRA* LCN FIGURE IN NJ, TO DISCUSS JOSEPH BONANNO AND HIS  
SON, "BILLY" BONANNO. IT APPEARS THAT "BILLY" HAS NOT BEEN  
ACCEPTING LCN DISCIPLINE AND HE AND HIS CLOSE ASSOCIATES, WHO  
ARE YOUNGER AND MORE BELLIGERENT THAN THE OLD-TIMERS WHO ARE IN  
CHARGE, HAVE BEEN A CAUSE OF CONCERN FOR THESE OLD TIMERS. SOME  
OF THE BLAME FOR THIS HAS BEEN CHARGED TO ZICARELLI AND DE CAVALCANTE, SINCE THEY PLED BONANNO'S CASE AT A TIME WHEN THE  
LCN FELT THAT THE BONANNOS SHOULD HAVE BEEN ELIMINATED.
