For information of the Bureau and Miami, a representative of the Central Office, U. S. Immigration and Naturalization Service (INS), advised IC JIMMIE C. WHITAKER on 6/4/63, that an alien file, Number A13139500, which is identical with captioned individual, is in the process of being forwarded to the District Office of INS, Miami, Florida, to be consolidated with captioned individual's alien file, Number A12854523.

It should be noted that alien file, Number A13139500 contained only one memorandum from the Department of the U. S. Navy, dated 10/6/62, the contents of which, as was noted above, is being furnished to the Miami Office of INS. The only other information contained in Central Office files concerning captioned individual was that he was ~~patrolled~~ ^{admitted} to the United States on 10/6/62. His permanent address was furnished as Calzada #3486, Vedado, Havana, Cuba. CALZADILLA gave his birth date as 12/15/28, and his place of birth in Oriente, Cuba. He arrived in the United States on PAA Flight 422 which originated in Havana, Cuba.

No further investigation is contemplated by WFO.

For information of the Bureau MM is conducting
background investigation in connection with captioned
individual.

MM has determined that BALBUENA CALZADILLA of
3031 N.W., 96th St., Miami, was born 12/15/29, Guantanamo
Naval Base and was employed approximately 20 years at the
Base. During the last three years of his employment, he acted
as an informant for ONI, furnishing pro-Castro information
both in and outside the Base. (S)(u)

MM requested WFO to check the records of [ONI and
INS for additional background information. (S)(u)

On 5/31/63, a representative of ONI, Washington,
D.C., advised IC EUGENE M. KIRKMAN that a file identifiable
with the captioned person is available but requested that a
review be conducted at the office of GEORGE DE MILLE, Pentagon,
FBI liaison personnel. (S)(u)

It is, therefore, requested that a review of
BALBUENA CALZADILLA's file be conducted by Bureau liaison
and the results furnished the MM Office.

WFO is awaiting the results of a check of INS
records and as soon as such is available will be furnished
to Bureau and MM.
