GUSTAVO MARIN

RemMlet captioned, "FRENTE NACIONAL de CUBA (FNC),
IS - CUBA", dated 11/11/74; MMlet to New York, 12/17/74,
and MMlets to the Director, 11/11/74 and 12/31/74 captioned,
"ABDALA, IS - CUBA."

Enclosed herewith for the Bureau are 11 copies
of a LHM dated and captioned as above.

MARIN is the leader of a group called ABDALA
and currently is the subject of a case entitled, "GUSTAVO
BIENVENIDO MARIN Y DUARTE, aka ET AL, NEUTRALITY MATTERS -
CUBA, Bufile 2-2079, NYfile 2-641".

In this investigation, there are allegations
of terrorist activities planned by ABDALA and MARIN himself
which are allegedly to be directed against Cuban Diplomatic
personnel as well as representatives of countries voting
in international bodies in favor of Cuba. (X)(u)

The NYO feels that all pertinent data on MARIN
concerning his alleged terrorist activities is being reported
in this case file mentioned above and accordingly the NYO
is placing this matter in a closed status. UACB.

Gustavo Bienvenido Marin y Duarte, also known as
Internal Security - Cuba

NY T-1, a Cuban exile, and currently associated with Gustavo Marin Duarte, advised that he is also an officer of the Frente de Liberacion Nacional de Cuba (FLNC), a Cuban exile terrorist organization which has claimed credit for bombings in Jamaica, Spain, Mexico, France and London in 1974. This source describes Marin as the national head of Abdala, a Cuban exile youth group with branches in the United States, Europe and Latin America, and he further indicated Marin is a school teacher who lives in New York City. This source also stated that Marin is on the Executive Committee of the Frente Nacional de Cuba (FNC) which was organized in August, 1974 in Miami, Florida to act as an "umbrella organization" to coordinate the activities of the different Cuban exile revolutionary organizations in the United States. NY T-1 furnished this information in the Fall of 1974. (X) (u)

On October 24, 1974, the Miami Herald, an English language newspaper, published daily in Miami, Florida, contained an article stating that the FNC had issued two booklets proclaiming its members as rebels. One booklet set forth the rules involving procedures and the other booklet set forth its statutes outlining the group's organizational scheme and goals. The FNC preamble stated that its members defy all authority and all laws except those coming from the people of Cuba. The FNC said it constitutes an open rebellion against any actions or laws issued against their liberation efforts and disavow any type of authority that does not originate with the Cuban people.

On October 22, 1974, NY T-1 reported that Abdala recently had withdrawn from the FNC and the FLNC because of a power struggle. NY T-1 said that among the influential Cubans who are members of Abdala who had withdrawn from the FLNC and the FNC and who were then talking about entering into (u)
