Throughout the interview, subject displayed a very
cooperative attitude and agreed to assist the FBI in matters
pertinent to the Cuban Field.

In view of the subject's willingness to meet
again with interviewing agents, should they require
assistance in matter relating to the Cuban Field, Newark
is closing investigation under the 105 classification and
will open a new 134 regarding MARRERO while further assessing
and developing his source potential.
