NK 5006-S on 1/28/75, had furnished information concerning an alleged trip of GUILLERMO NOVO during December 1974 to Santiago, Chile, where he was alleged to have conferred with a representative of the military junta, whose identity is not known. *(S)(u)*

NK 5006-S at this time stated that the general rumor regarding NOVO's trip was that support either financial or military had been offered to the Cuban exiles. NK 5006-S also stated that Dr. ORLANDO BOSCH, a Cuban exile leader, currently was in Santiago and that GUILLERMO NOVO conferred with ORLANDO BOSCH. *(S)(u)*

NK 5006-S on 4/3/75 and NK 5775-PSI on 4/7/75, reported information relative to GUILLERMO NOVO's trip to Santiago, Chile, and stated that reports were that NOVO had conferred with Dr. ORLANDO BOSCH, head of the Cuban exile organization called Accion Cubana (AC). NK 5775-PSI and NK 5006-S stated that it was their understanding that GUILLERMO NOVO had made this trip with a false passport and very possible this passport may have been given to him by the Chilean government. Both sources stated, however, that they had no specific facts to substantiate this reported trip of GUILLERMO NOVO. *(S)(u)*

NK 5775-PSI on 4/7/75, stated that GUILLERMO NOVO continues to be employed as a salesman for Center Ford in North Bergen, NJ. NK 5775-PSI also reported that GUILLERMO NOVO is alleged at the present time to be a solicitor of financial *(S)(u)*
