Enclosed for the Bureau are five copies and for Newark one copy of an LHM dated and captioned as above. One copy of this LHM is also being disseminated locally to INS.

ADMINISTRATIVE

Although ESTRELLA RUBIO is a woman of questionable morals and has a background of illegal activities, she is not believed to be directly involved in terrorist activities. She is too old and considered to be, by most Cuban exiles, too talkative and untrustworthy.

During interview of RUBIO, she only furnished marginal information to interviewing Agents and was evasive. She gave false information regarding her last contact with IGNACIO NOVO of New Jersey. ELA

MM 2960-S advised that ESTRELLA RUBIO said that she would be willing to work for the FBI for this could give her an opportunity to earn money, and would place her in a position to furnish information against those she did not like or trust. At the same time she added that she would not inform on people who she considered to be her friends and political allies. (X)(U)

On April 8, 1975, MM T-2, an exile Cuban with information regarding exile Cubans in the Miami area, advised that ESTRELLA RUBIO is not an activist per se. *(S) (u)*
